A drilled well was put in operation in 2010 at the building site & a windmill w/force pump supplies water to sev locations around the building site by gravity from the 1500 gal supply tank. A 30x96' greenhouse will be offered to the successful bidder only for an additional \$3000. This farm could possible qualify as an organic unit. There is an extra lg garden space w/a well started strawberry bed & raspberry patch.
